Code Officer Report Selectboard Meeting

September 5, 2017

Permits Issued:

One Building Permit and Shore-land Zone Permit within the Limited Residential District were issued to construct a breezeway connecting an existing house and garage located off Bear River Road. One Building Permit for a single family dwelling with five bedrooms and four baths on Upper Road in the Glades Subdivision with associated Plumbing and Wastewater Permits and one Building and Plumbing Permit for a kitchen remodel at a North Peak condo.

Road Items:

Cross Excavation has completed road shoulder-ditch shaping on Skiway Road, Greenbriar Road and portions of Timberline.

Lucas Striping has completed road striping and curb painting including new solid double yellow center stripes on the Sunday River Road from the Monkey Brook Intersection to the end of pavement.

The depression over a culvert on the Roderick Road has not shown signs of growing. If that trend continues, the plan is to have B. A. Manzer patch the spot, to include driveway gravel installation.

A Maine DOT crew will be connecting the Artists Bridge guardrails to the concrete bridge rails at no cost to the Town, MDOT is hopeful to complete the task before freeze up. Connecting the Simmons Brook Bridge guardrails to the concrete bridge rails, the Town will be responsible for. In consulting with MDOT and Superior Services, a Michigan shoe connection will not work, both suggested the Town could modify a successful connection to lessen the existing deadly fixed object in the right of way factor.

The road sign order has been received, installation should occur by the end of September.

Other Items:

Mountain House: The Planning Board has scheduled on Sept 6; a Site Visit on premise at 5:30pm, a Public Hearing at Town Office at 6:30pm and their Planning Board meeting to follow at 7 pm.

Mr. Conkright is scheduled on Wednesday Sept. 13 at 6 pm at the Norway Town Office to attend the upcoming two hour emergency management G402 course put on by Oxford County Emergency Management Agency for newly elected Town Officials.

Goodwin's Well and Water is scheduled August 28 to install water filtration systems at the Town Office and Grange Hall.
