Other Items

The owners of 53 Barker Mountain Road have voluntarily complied with the Notice of Violation written August 1 by providing, via email attachment, a survey stamped by Gary Inman PLS # 2078 October 3, 2019 depicting the deck type structure supporting a hot tub being 10.47 feet from their property line, proving the structure is not located within the required ten foot property line setback. I would suggest as depicted on the survey, no property line setback violation exists, therefore resolving the Notice of Violation.

As a result of 2007 Legislative inquiries and discussions focused on LRAP, MaineDOT needs to collect additional information on the uses of LRAP funding of all Maine municipalities, counties, and Indian reservations. This form is intended to be simple and provide an easy method to collect information on the use of over \$20 million per year by local agencies.

- 10. Bridge or minor span replacement and rehabilitation
- 11. Any bridge repair activities with a ten-year life
- 12. Local share of a Municipal Partnership Initiative (MPI) project on a state road
- 13. Debt financing/bond repayment for past capital improvements to public roads
- 14. The urban match component of any federal-aid project
- 15. "Banking it" to save up for a future project
- 16. Other (explain)
- * Some of the categories of work (# 5, 6, 7, 8 & 9) qualify as capital improvements, but must be done in conjunction with roadway reconstruction/rehabilitation.

Re: Med-Care 2020 Subsidy Increase

Dear Selectmen,

Northern Oxford Regional Ambulance Service, DBA Medcare, was created to provide paramedic level ambulance service to the member Towns. We all agreed that no Town could do it alone but believed that, co-operatively, we could do what all the Towns needed and that we could do it keeping the town's contribution as low as possible. Over the last 30 years Medcare ambulance has provided the service under the ground rules agree to at its inception.

The last 5 or 6 years have been more difficult. We have struggled trying to meet the service's needs by keeping the subsidy as low as possible. As you well know, it has been difficult to do and we have needed to increase subsidies. We are still not in a good financial position and are looking at increasing subsidies again.

There are three reasons why we must increase subsidies:

- 1. Minimum wage has increased from \$9/hour in 2017 to \$12/hour in 2020. In order to maintain a legal and equitable wage scale, this change will now affect virtually all employees. The cumulative effect of the minimum wage changes since 2017 will result in payroll expenses in 2020 of \$144,500 more than if wages had increased at 2% rate through that same period.
- 2. Because of the effect of the Affordable Care Act (ACA), our revenues have continued to decline while our call volume is generally increasing. Medicare only reimburses us at eighty percent of our charges and Medicaid at around fifty percent. The Insurance companies have adopted the Medicare rates for all intents and purposes. The ACA has resulted in insurance companies offering insurances that have high deductibles. Because we are the initial provider of services, we feel the heaviest impact of the deductible. The deductible amount falls on the individual receiving our services as part of our Self-Pay revenue. Even though we try diligently to collect this amount, it is very difficult. We use a collection service and have an aggressive collection protocol, but many people do not to pay.
- 3. In trying to keep subsidies low through these rising costs and reduced revenues which are beyond our control, we have allowed our fleet to age. Most of the equipment purchased in recent years have been done through financing. Continuing to borrow only increases interest expense and operating costs.

In building our 2020 budget we must address these shortfalls. To address the operational shortfalls caused by the decreased revenue and increased expenses outlined above a subsidy increase of \$11 per capita is required.

Additionally, the organization is in immediate need of a replacement ambulance. We can no longer continue to borrow for capital assets. This is only worsening our financial position. The board has approved an additional \$6 per capita for capital needs. This will result in a total subsidy increase of \$17 per capita bringing the total assessment to the towns to \$45 per capita. This will allow us, to meet the minimum equipment needs, pay down dept and will put Medcare on much firmer financial ground for the future.

The executive committee of Medcare will host an informational session regarding these changes on October 23, 2019 at 7 PM at the Medcare base, 290 Highland Terrace, Mexico.
