UNIFIED DEVELOPMENT REVIEW APPLICATION

PRE-APPLICATION CONFERENCE

Reference: (a) Unified Development Review Ordinance, Section 9

Purpose: This is an optional conference between the Applicant and the Planning Board. The proceedings are informal with the intention of:

- 1. Allowing the Applicant to introduce themselves and to present, in conceptual terms, their development.
- 2. Allow for a question and answer period where the Planning Board may make suggestions for the Applicant to consider when preparing their subsequent submissions.
- 3. Establishing the required contour interval on subsequent plans. The Planning Board may hold an on-site inspection of the property prior to determining the required contour.

Submission: The pre-application submission shall include:

- 1. This form as a title page.
- 2. Applicant/Owner/Agent information, UDRO Form 10.1
- 3. A Sketch Plan showing the proposed layout of roads, lots or units, structures and other features in relation to existing conditions. The Sketch Plan may be be a freehand penciled sketch. See ref. (a) for more details.
- 4. A request for a Pre-Application Conference, along with the information detailed above, needs to be submitted two weeks prior to a scheduled meeting of the Planning Board.
